21 above-captioned matter, pursuant to Title 18, United States Code, Sections 6002 and 6003, and  
22 respectfully alleges as follows:

23 1. The United States has subpoenaed Mohamed Ali Moussa to appear and testify at  
24 the trial of the above-captioned matter.

25 2. The witness previously appeared before a Grand Jury in this District on July 20,  
26 2004. At that time, the witness invoked his privilege against self-incrimination under the Fifth  
27 Amendment when he appeared to testify. Mr. Moussa is now represented by counsel. Mr.  
28 Moussa's lawyer has informed the United States that Mr. Moussa will invoke his privilege
