Ali: That is good,

Amr: Ah, did you receive, what do you think of the materials that I sent you?

Ali: Amr, it looks fine but the thing is: how the lawyer is going to handle that?

Amr: Ah. It is like which came first, the egg or the chicken? (laughs)

Ali: Yeah, I know.

Amr: You see. They would not do anything until they know what you are thinking and what you're planning on doing.

Ali: Yeah.

Amr: Unless the thing is consistent. He is not well organized.

Ali: Yeah.

Amr: So.

Ali: The important thing right now, the thing that is going to reverse the subject, are the guys from the east.

Amr: Ah.

Ali: Give them a drill and they need to understand that they (UI) of the case.

Amr: Ah, exactly.

Ali: This is the most important thing.

Amr: I agree with you.

Ali: If they bring up this subject.

Amr: Yes.

Ali: It would change the whole thing.

Amr: Exactly.

Ali: And what you did is not going to help at all.

Amr: What.

Ali: It is not going to affect anything. It is going to reverse **the** whole case.

Amr: I know.

Ali: That is the most important thing.

Amr: Ah.

Ali: All the people that know about this matter told me that this is the most important thing.

Amr: **Ah.**

Ali: How they change the whole thing. It is the same story.

Amr: Ah, ah.

Ali: The second thing that you need to do is to buy time to fire those sons of bitches.

Amr: Time for what?

Ali: Time, you need time.

Amr: Yes.

Ali: You need to go to the hospital.

Amr: What do I need?

Ali: Be admitted to the hospital.

Amr: Do you think?

Ali: Yeah.

Amr: Speak louder, dear. It is too noisy here

Ali: Six months in the hospital.

Ali: For the other lawyers.

Ali: Do you understand?

Amr: Exactly and they tell me that the hospital has better care. Here, anytime I ask for something it takes them two weeks to answer me.

Amr: Alright, alright

Ali: And quit telling them that you need a hospital in California

Amr: Alright.

Ali: It's not going to help.

Amr: It is not helping. Does Hussain Hanfi call you?

Amr: Hussain Hanfi

Ali: Who is Hussain Hanafi, the one in the east?

Amr: The one in New York

Ali: Yeah, he called me

Amr: He works for IBM

Ali: But I didn't talk to him much and I told him to send me an email and I called him on the phone.

Amr: **Ah.**

Ali: Does he know anybody

Amr: The idea is to have him do something regarding the contradiction of the marketing.

Ali: The rest of it is useless

Amr: I need some help with this matter.

Ali: Don't forget that I..

Amr: Because the one that I have here don't know how to do anything.

Ali: I can't say it. I call people and I am telling you that son of a bitch lawyer of yours, Dan, does not want to tell me anything.

Ali: You are in jail and you can't think straight, you see?

Ali: No matter what you do, you see.

Amr: Yes.

Ali: The things that you think about for hours are all related to the case.

Amr: Yes.

Ali: You have to think outside the case. Think of the simple thing that started these things.

Amr: Other than calling Dan what else do you need?

Ali: What?

Amr: I am going to try to call Dan so he can provide you the information. What else do you need, Ali? Is the summary good?

Ali: The summary is good but it explains the details of the case.

Amr: Alright.

Ali: This is not new, Amr.

Amr: I know, I know but there are several summaries.

Ali: What?

Amr: There is a summary that has about 60 items, you see.

Ali: I have that.

Amr: That summary explains things in general and there is another summary that explains how the things relate to each other, as far as the judge is concerned, and what happened 3 weeks ago and what happened last year.

Ali: Yes.

Amr: Did you get that?

Ali: No, I have not gotten that yet.

Ali: Because if his decision is reached and it is different from the present one, the situation will not be safe.

Amr: Alright, alright but the one who is coming now is coming regarding the incompetence matter. The insanity defense man will be coming from where the one came to me earlier. I was doing other tests with him. The man who is appointed by the court is going to concentrate on the competence only.

Ali: Alright.

Amr: Give me a few days to call Dan Bookin and I'll call you and let you know when to call him.
